3. Copy of Māori Trust order (if applicable).	
4. General location map.	
5. Map showing boundaries of the landholding, the forest sink area, road access, and forest blocks.	
6. For areas greater than 50 hectares: a geospatial data file derived from an orthographically corrected aerial photograph or a survey plan capable of being deposited under the Land Transfer Act that verifies the boundaries of the forest sink area ¹ . For areas less than 50 hectares: a data file as above OR GPS coordinates of the boundary of the forest sink area ¹ .	
7. Completed forest sink plan.	
8. Evidence of land eligibility: may include aerial photographs and oblique photographs of the property taken at or around 1990 and farm records which demonstrate the use of the land as at 31 December 1989.	
9. Application fee: cheque enclosed, or credit card/internet banking details with Unique Identifier.	

¹ The data file or GPS information supplied must identify the coordinate system used. NZ Transverse Mercator projection is preferred.
